- 3. The- functioning of Research groups to promote better quality research and publications has been Strengthened.
- 4. Value addition by certification programs as well as technology training is focused through Skill Development Centre.
- 5. Departmental initiative for placements in core domains other than central Training and Placement cell
- 6. Student participation in Innovation, Incubation and Entrepreneurship activities.
- 7. Continuous inputs from all stakeholders like Alumni, Academicians and Industry experts are taken to Improve the curriculum on regular basis.

Suggestions for improvement:

- Sponsored research and consultancy is limited to a few departments. The faculty members of other departments have to be motivated towards applying for sponsored research projects.
- 2) Research output by a way of publications in SCI / Scopus indexed journals needs a substantial improvement.
- 3) Motivate the faculty without PhD to pursue the PhD as a priority.
- 4) As the college has strong Alumni, efforts are needed to utilize their expertise to guide the students in terms of Technologies, Training, Projects and Placements.
- 5) Placements are majorly in software for most of the branches of engineering. Efforts are required to invite core companies especially for EEE and ECE branches for campus placement.
- Industry-Institute interaction should be strengthened.

Consultancy activities are available only in CE department. Other departments shall also explore their potential and extend Consultancy activities.
