ORDER:

1. The “KSRM College of Engineering, Yerramasupalli (V), Kadapa” was given Temporary affiliation for running Degree courses during the academic year 2022-23 vide Procs.(1) read above.
2. The AICTE, New Delhi and Government of A.P have accorded extension of approval to the above college for the academic year 2023-24 vide ref (2) & (3) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2023-24 vide Procs. (4) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (5) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2023-24 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report on 15-02-2024.

1. Accreditation of the Engineering departments is mandatory
2. Faculty are to be trained in thrust and emerging areas
3. Barrier free environment is to be provided at all floors
4. Five ratified Associate Professors are not having qualification (Ph.D) according to the norms given by the University.
